### MISSION STATEMENT

SOMA Medical Assessment Services Corporation strives to provide quality assessment services to persons served, while upholding the rights of persons served without exception. ### SCOPE

- 1) **Geographic Areas Served** – Assessments are conducted throughout Canada, with the main service Centers located in Vancouver, BC & Vaughan, ON.
- 2) **Settings** – Assessment Services take place at assessment clinics, physicians’ offices, chiropractic, physiotherapy and occupational therapy clinics, at examinees’ homes (in-home assessments), at examinees’ job sites (job site, job demands, physical demands, and ergonomic assessments), as well as at acute and long term care hospital and forensic based settings.
- 3) **Days/Hours of Services** – Service Centers are officially staffed from 7:30 am to 5:30 pm local time Monday through Friday; however, we do accommodate requests for weekend and evening services to accommodate persons served.
- 4) **Referral/Payer Sources** – Payer sources include: Property & Casualty insurers; Life & Health insurers; worker compensation boards; employers; law firms; and government agencies.
- 5) **Services** – The specific services offered include:
  1. Medical Examinations by all Medical (MD) disciplines.
  2. Functional Capacity / Ability Evaluations by Regulated Health Professionals.
  3. Cost of Future Care Assessment by Regulated Health Professionals.
  4. In Home Assessment by Regulated Health Professionals.
  5. Accessibility Assessment by Architect/Engineer.
  6. Vocational Assessments by regulated professionals.
  7. Transferrable Skills Analysis by regulated professionals.
  8. Labour Market Survey by regulated professionals.
  9. Neuropsychological and Psychological Assessment by PhD level Assessors.
  10. Job / Physical Demands Assessment by Regulated Health Professionals.
  11. Ergonomic Assessment by Regulated Health Professionals.
  12. Medical File Review / Paper Review by all medical and allied health professionals.

13. Arbitration and/or Trial Preparation and Attendance by all medical and allied health professionals.
14. Catastrophic Assessment by CAT certified assessors (specific to Ontario).
15. Claims Review Committee by all medical specialties (specific to British Columbia).
16. Medical Status Exam and Certified Examinations by all medical specialties (specific to Alberta).
17. Addictions Assessments and DOT Addictions Collections.
18. Coordination of Transportation, Interpretation/Translation and Lodging Services.

**6) Demographics** – SOMA regularly conducts assessments of children (2+), adolescents and adults. Further exclusion/inclusion criteria may be based on the examinee’s physical and mental stability/acuity, as well as general health and safety considerations, specific to the referral. In 2018, SOMA served examinees from three to 90 years of age. The total number of children/adolescents served was 25, in the following age ranges: infant to age 5 = 3; age 6-13 = 7; age 14-18 = 15.
